# Do Non-Fiscal Policy Items Belong in The State Budget?

When is a budget not a budget? Sounds like a riddle one of your children might ask you. Unfortunately, this question as it applies to the State of Wisconsin's budget does not have an answer that makes you chuckle.

The man on the street assumes that the state budget is similar to your household budget or the annual budget a business might put together. Where are you going to get your money from and what are you going to spend it on? Would it surprise you to know that the state budget is not quite that simple? Probably not, but you might be surprised to know what makes it so complicated (*read: messy*).

Governors (or legislators) who want bills to pass without having them considered individually amend them to the budget bill. Once it is under the umbrella of the budget bill ("under the Christmas tree" as some people call it), it is very difficult to get it removed. People are generally more worried about the big ticket items in the budget and let the minor amendments pass without as much review. Often these are bills that would not have enough appeal or support to pass on their own. The Wisconsin Legislature has a habit of debating the budget until the deadline for passage has passed and will approve most anything to get this item of business out of their way.

We are not talking about appropriations. We are talking about actual policy items that have nothing to do with the budget. Spending should be in the budget; but should a modification to the time period for claiming an instant lottery prize really be there? When the governor signs the budget in to law, these items which were inserted in the budget also become law. The taxpaying public never knows what hit them.

That example seems pretty innocuous but the "non-fiscal policy items" are not always so simple. For example, a repeal of the Qualified Economic Offer (QEO), the guaranteed raise for teachers, which had been proposed by the Governor, was also included in the budget. That would be considered a major policy initiative.

Why Governor Doyle included a provision eliminating a guaranteed raise for teachers from state law tells you something about why we need the QEO in this state until we can get spending controls for all aspects of state government. It is also a likely topic for another day.

Some of the non-fiscal items included in the last state budget included:

- In-state tuition for the children of illegal immitgrants..
- Same-sex partner benefits.
- Mandatory auto insurance limits.
- Unionizing Home Health Care Workers.
- Allowing the University of Wisconsin System and Staff of Unionize.
- Enforcement of seat belt laws.
- Mandatory Auto Insurance.
- Prohibiting communities from making cuts in emergency dept. Budgets such as police and fire departments.
- Mandating that any construction project in Wisconsin, either public or private that receives public funds pay every employee who works on the project be paid the prevailing union wage scale.

To their credit, the co-chairs of the Joint Finance Committee, the state's budget committee, agreed to remove many of the offending "non-fiscal policy items" from the state budget proposal and have them drafted as separate bills.

We acknowledge that some of the non-fiscal items included in the budget could have merit and possibly could have passed the legislature on their own through normal, open procedures. However, most of them seem to specifically benefit the major contributors and supporters of the governors administration, namely the teachers union (WEAC), trade unions, and personnel injury law firms.

Including last minute non-fiscal items, and for that matter specific spending projects in the state budget is not a new problem in Wisconsin. It is referred to Pork-Barrel spending in the Federal Budget. It is largely the cause of much of the reckless spending authorized by Congress each budget year in order to reach agreement on a budget to present to the President. "You vote for my request for funding for this project in my district and I will vote for yours," has been the password. With stimulus funding now being a factor Congress doesn't even have to wait for the budget to come along.

Historically Wisconsin law mandated a balanced budget be presented to the governor. A few years ago when spending requests began to grow beyond income projections the governor was given the authority to personally veto or reduce items he deemed unnecessary or inappropriate from the budget; subject to legislative override.

Great idea while it worked. If the new governor has any idea of balancing the budget and reducing the huge deficits which are accumulating he will have to learn to say "no" once in a while.

### Why Should We Consider Replacing **Our Income Tax System With the** FairTax?

There are three major reasons; Responsibility, complexity, and cost.

#### On responsibility:

- \* 47% of workers pay no income tax. That means they don't care if income tax rates go higher. They will vote for more entitlements.
- \* If these people don't understand how other types of taxes impact them they could care less about those tax rates.
- \* Illegal aliens pay no federal taxes at all.

#### On complexity:

- \* Our tax code is 70,320 pages long. In 2003 it required 200 million
- \* Our taxes include income, payroll, corporate, gift, estate, capital gains, self-employment, alternative minimum taxes, tariffs, and excise taxes at various rates.
- \* It takes an average 28 hours and 30 minutes to fill out the forms.
- \* That is 7.6 billion man hours per year. That is an additional tax.

#### On cost:

- \* There is the cost of complying with our tax system.
- \* There is the tax gap also called the cost of non-compliance.
- \* There is the revenue not collected from the underground economy.
- \* There are hidden taxes that add 22% to the cost of goods and services
- \* The time spent on tax forms could have better uses.

#### Clarifying the annual cost of our tax system.

According to the Tax Foundation the cost of complying with our tax system is \$388 billion per year. 388,000,000,000.00

What the Tax Foundation does not address is what that \$388 billion could do for the economy if a different tax system were in place. What positive effects could that money have if not wasted every year? Does two percent growth or \$7.76 billion per year sound reasonable? \$7,760,000,000.00

The tax gap or the cost of non-compliance is \$365 billion, \$290 billion after lawsuits. There is no mention of what these lawsuits cost. \$290,000,000,000.00

Because of this tax gap Americans must pay an additional 32.1% in income taxes.

#### What The Federal Tax System Is Costing You.

In Eric Schlosser's book Reefer Madness he makes it clear that the underground economy is \$1 trillion. There are no taxes collected from it by our tax system. The FairTax would collect \$300 billion. The underground economy is made up of drugs, pornography, and crime on which no taxes are currently paid.

#### THE FAIRTAX SOLUTION.

The FairTax replaces the income, payroll, corporate, gift, estate, capital gains, self-employment, and alternative minimum taxes with a national retail sales tax.

- 1. No federal tax withholding. You will still pay state income taxes. States that "piggyback" the federal tax system, like Wisconsin, will either copy the FairTax or have to create their own income tax system. You will keep the 10% income and 15.3% payroll taxes.
- 2. Only retailers will fill out tax forms. They will retain 1.25% of the FairTax collected to cover accounting costs. States collecting the Fair-

Tax will also retain 1.25% of the FairTax collected also for accounting. States send the FairTax to the U.S. Treasury.

- 3. The prebate is intended to cover the cost of the FairTax on necessities. Illegal aliens will not receive the prebate and will help fund our government. Tourists will not receive a refund and will also help pay for our government.
- 4. Our economy gains \$1 trillion by enacting a tax system that saves money and is more effective at taxation.
- 5. Smile, retire earlier, send your kids to college, or buy a home.
- 6. Removal of hidden corporate and payroll taxes drops all prices roughly 22%. The addition of the FairTax makes prices about the same as they were before the FairTax. According to Section 902 of The Fair-Tax Act of 2009, businesses will be reimbursed for hidden taxes in their inventories for a maximum of two years. When that period passes we will see prices drop to their real value.

#### **OTHER GAINS**

Of 500 CEO's of foreign companies, 100 said they would build their world headquarters here when the FairTax passes. The rest said they would build their next manufacturing plant here. That could mean a large number of jobs for Americans.

There are roughly \$13 trillion locked overseas because of our 35% corporate tax. Companies cannot afford to bring that money home under our current tax system. It is likely that that money will come home under the FairTax. This money would obviously be used for capital investments in current U.S. businesses and more jobs.

The psychological impact of taking home your gross pay will be beneficial. We will no longer be required to maintain records of savings, or investments. The stress of filling out tax forms will be only a painful memory. April 15th will be just another nice spring day.

The National Taxpayers' Union is supportive of the FairTax. Wisconsin has several candidates running for the House and the Senate who support the FairTax. Reid Ribble states on his website, "The FAIR TAX legislation, like the flat tax concept, needs to be explored and voted upon because either option is far superior to the tangled mess we currently have."

Americans for Prosperity (AFP) has been working with Fair-Tax promoters in many states.

#### A Flat Income tax.

There has been some discussion of a flat income tax. This is how our income tax began in 1913. In 1986 we reduced it to four income tax rates. Steve Forbes owns the Heritage Foundation. He ran for president on a flat tax. You will find that the Heritage Foundation focuses on only a flat income tax as the solution. Dick Armey is also a myopic supporter of a flat tax. My sense is that these men's egos will not allow them to adjust their points of view. By definition an income tax may never be simple. We would still have tax forms and thousands of lobbyists seeking exemptions for their clients. We held national debates in many cities between the FairTax and a flat tax for over a year. The people attending the debates almost unanimously and continually chose the FairTax. The FairTax inclusive rate is 23%.

#### **August Meeting Notes.**

#### Brett Davis Speaks to BCTA.

Monthly Brown County Taxpayer Association Meeting August 19, at Titletown Brewing Co. Vice-president Rich Carlstadt presided.

Brett Davis, candidate for Lieutenant Governor, presented his proposal for changing the role of the Lieutenant Governor of Wisconsin. He currently represents the 80th Assembly District in the Legislature. This district is located southwest of Madison and includes Oregon, Monroe, and New Glarus. He was first elected to the State Assembly in 2004, and was reelected in 2006 and 2008. He has experience in the private sector as a Realtor.

Representative Davis proposes to transform the lieutenant governor's office or eliminate it. If elected, with the blessing and authority of the governor, he plans to use the resources of the lieutenant governor's office to focus on finding fraud, waste and abuse in state government.

He explained that the cost of doing business in Wisconsin is too high for state firms to consider expanding their operations within the state. High taxes, excessive regulation, and delays in permitting combine to create a hostile climate for business expansion in Wisconsin. We must stop punishing job creation in Wisconsin.

Actions Representative Davis says are necessary to put our state government back on track include:

- \* Line-by-line budget review using the principles of zero-base budgeting. Bureaucrats must move beyond their "spend it or lose it" mentality.
- \* Streamline permitting processes to remove obstacles to business startups and expansions.
- \* Start to address the state's \$2.9 billion structural deficit and begin to reduce it.

Questioned about the costs of government employees' pensions and healthcare insurance, Representative Davis stated that they must contribute toward these costs.

Asked why he was a sponsor of the 2005 Ethanol bill in the Assembly, he said we must move beyond corn-based ethanol and he now opposes corn-based ethanol production.

Rich Carlstedt reported that the Ashwaubenon School District held its annual meeting on July 26. Citizens of the district were allowed to vote on the budget, approving a one percent increase.

The next meeting of the BCTA is scheduled for Thursday, September 16, at Titletown Brewing. The speaker will be Al Ose, Wisconsin and Iowa Regional Director of "Americans For Fair Taxation." Details on the last page of this TAX TIMES.

#### **National Debt Update.**

At the end of August, 2010, the United States National Debt reached a total of \$13,394,745,197,209.00. This represents an increase of about \$124.14 BILLION since last month at this time, or an increase of \$4 Billion or so each and every day.

It had been increasing at \$3.5 Billion per day, but apparently Congress decided this wasn't doing enough for the country. In fact, we have heard several reports of calls for more stimulus spending because what has already been spent has done so much good. According to the Census Bureau, unemployment is now (up to/down to) take your choice 25,307,048. That's 25 Million, which is a lot of people not working or paying taxes.

Other items of interest are that each U.S. Citizen owes \$43,191 towards the debt while each taxpayer owes \$129,686. The government finally figured out that not everyone pays taxes.

Just remember that every time the President proposes a new stimulus plan you will end up digging a little deeper.

# Things That Make Us Wonder.

#### CALIFORNIA'S DEBT EXPLAINED.

While Green Bay and other Wisconsin cities struggle over their school budgets and the need to build new facilities from time to time, the City of Los Angeles is opening a new 4,200 student K-12 school with a total cost of \$578 Million. The countries most expensive public school ever.

What is puzzling is the Los Angeles School District already has a \$640 Million deficit and a record of some of the worst performing schools in the nation. We don't know if they held a referendum to approve this school but do know that California voters have a habit of voting for things that are impossible to pay for. They have had massive teacher layoffs due to budget problems. It will be interesting to see if the new school makes things better.

#### MORE LOBBYISTS THAN LOBBYEES.

A Journal-Sentinel article relates that 749 registered lobbyists in Madison have spent \$17.7 million so far this year in efforts to influence our legislators. Considering there are only 33 State Senators and 99 Representatives it would appear that they are somewhat outnumbered.

The biggest spender was WEAC spending \$2.1 Million. They got the repeal of the QEO which allows a 3.8% annual increase in teachers salary and benefits. Actually taxpayers are also paying for the lobbyists considering WEAC is sponsored by deductions from payroll deductions.

Other major lobbying groups include various tribal interests, insurance companies and tobacco companies.

#### DOYLE'S OWN ZIPPIN PIPPIN.

Despite a lot of unanswered questions including the need for the project in the first place, Gov. Doyle is moving full speed ahead to get his "high-speed" rail project locked in during the few months he still has remaining in office.

In addition to approving a depot in downtown Madison, groundbreaking is scheduled to begin in October on a \$18 Million train shed at the other end in Milwaukee. Altogether \$300 Million in contracts could be let this year. Apparently the Gov. believes this to be the top priority for use of the states limited resources if any-

one ever rides it or not.

#### PREPARE FOR REDISTRICTING.

When the 2010 Census results are finalized, it is possible that Wisconsin will lose one of it's 8 Congressional Seats. A penalty for slow population growth.

It will be necessary to reestablish the boundaries of the remaining districts and the next Legislature will have to draw a balance between political, population and geographic considerations.

#### **HOW ACCURATE THE COUNT/**

We are all aware and concerned by the large numbers of unemployed. The huge cost of unemployment and other benefits paid less the loss of tax revenues is significant and worrisome.

One problem is actually putting believable figures to the actual number of unemployed. While the Dept. of Workforce Development is responsible for tracking the number of unemployed, the actual rates can be misleading. Using the number of new claims each month as a gauge does not account for those already seeking work. We have politicians running for state office claiming records of job creation when the actual number of unemployed under their watch is sky high.

Finally with federal money available for the asking are high unemployment numbers used as a tool to obtain stimulus funds for whatever purpose?

#### THE COST OF SAFETY.

While the recall of half a billion or so eggs due to fear of Salmonella was probably a necessary move, it is always discouraging to see otherwise good food products destroyed. The loss to the producers will be devastating.

While the Food and Drug Administration is acting in good faith in our behalf, the nations personal injury lawyers will finish the job.

#### GET YOUR FREE GOVT. MONEY.

We realize that if is difficult for the government to track every penny it spends or authorizes. We also realize that whenever government money is made available, a certain class of individual will figure how to get their hands on it whether they need it or not while those for whom it was intended still suffer. Such is

the nature of political handouts.

A recent *USA Today* article reported that 1,295 prison inmates were able to qualify for \$9.1 million in first time home buyer credits even though some of them were serving life sentences at the time they made their application. Thousands of other individuals received credits even though their claims were fraudulent.

#### WHAT'S IN THE CAP AND TRADE?

So far the proposed Cap and Trade bill has been buried in committees waiting for the right time to push it through, for the Presidents signature using the same methods as with health care and finance reform. Designed by special interests, pushed through by lobbyists, with thousands of pages of double-talk that nobody really reads or understands except that it sounds good.

From what we have read so far, this would be even more disastrous to the country as a whole than the Health Care bill.

## \* \* \* \* \* WATER RATES COULD INCREASE.

The Wisconsin DNR has proposed new rules, fees, registration, etc., on all large volume users (100,000 or more gallons per day) of Great Lakes water. This includes municipal users so if enacted look for even higher water bills. Fees collected would be used to gather information on how much water is being used and what it is used for.

While they are at it why not more fees on what is dumped into the lake? Like Milwaukee after a rain storm.

#### LET'S SELL CITY HALL.

An article in the August 23, *Wall Street Journal* offers a number of ways various municipalities are raising money to balance their budgets.

Deals in the works include the sale of airports, city owned buildings, parking meters, and even zoos. In most cases the city would sell the asset to private parties and then pay a monthly fee to use them. While this made funds available for immediate needs, the cost to taxpayers was usually higher over time.

A couple of years ago Chicago made a deal to sell it's 36,000 parking meters, but the company that bought them did such a poor job of maintaining them that the city figures it lost about \$1 Billion in revenues on the deal.

#### HOPE FOR THE ECONOMY.

There are a number of things effecting the economy. Some good and some obviously bad. A *Journal/Sentinel* article points out that perhaps business would be more positive if they had a better idea of what will happen in Washington.

The future of Health Care mandates, individual and corporate taxes and political mandates all contribute to business delaying plans to expand or hire.

#### HELP FOR THE HUNGRY.

While there has been some drop in Brown Counties unemployment rate, it is reported that over 10,000 households in Brown County use Foodshare Federal assistance for obtaining groceries. The state director of the program claims the number could be even higher but many people are unaware of aid programs that are available.

#### THE FUTURE OF ENERGY.

WE Energies coal powered generating plant in downtown Milwaukee is estimated to emit 10 Million pounds of sulfur dioxide, 3 Million pounds of nitrogen oxide, 699 million pounds of particulates, and 2.8 Billion pounds of carbon dioxide into the air each year. While that sounds like a lot of pollutants and we question their accuracy the report is that the DNR and EPA have been holding up renewal of the plants operating permit pending either an update to the plants system. Options include new pollution controls or switching to natural gas.

We don't know how this plant compares with the thousands of other coal burning energy plants around the country, but we would imagine it would take a tremendous number of windmills or solar panels to equal the amount of energy it produces. We also know that while natural gas may be cleaner and available today, the supply is not infinite and burning it to provide electricity may not be the best use of this precious resource..

One question may be is this plant that bad or do other coal burning plants have devices that reduce pollution that would be a better option.

Isn't it really time our elected officials really get serious about conserving and preserving energy for the future as well as the present environment? This is one area where we need more crash programs.

#### BE CAREFUL WITH BLISTER PACKS.

Every so often the consumer safety people issue a warning about something or other they deem dangerous to our safety and even issue their guesstimates of how many people are hospitalized with injuries each year as a result.

I would like to nominate those heavy-duty plastic blister packs that manufactures and stores are so fond of using to display items while discouraging theft.

After you purchase them, most of them are virtually impossible to open without special tools which you never have available when you need them. You cut yourself very easily in the process, and when you do succeed, you cannot easily reseal the package if desired.
