No Harmony in this September Song.

Something I've learned in 16 months serving on Green Bay's Common Council is that you can't predict what issues will emerge, and which of them will provoke the press and public. The latest example is the potential of Walmart pursuing a downtown store on the north end of the vacant Larsen Green property on North Broadway. Like most, I was surprised by the idea since we're all accustomed to seeing Walmarts in edge-of-town settings, and the notion of one in an urban center is a break from the norm. From the contacts I've received, the debate over this idea will be fascinating since just about every constituency will likely be divided.

First, I expect division among the businesses in the Broadway district. Many are boutique type shops with owners who think the area should be populated with similar outlets to further solidify a unique character to the area. But others, like food and drink establishments, may believe they will benefit from the additional activity and commercial traffic. It's interesting that the organization formed, funded, and directed by district businesses, On Broadway Inc., is the party pursuing the Walmart idea. Does this signal support from Broadway businesses, or is it driven by On Broadway's desire to get out of its ownership (and payments) on Larsen Green?

Second, I know from contacts I've received there will be division among city residents. Some think the opportunity to bring a successful large business into a blighted area, increasing the tax base and reducing risk (the city guaranteed On Broadway's Larsen Green loan) is a great idea. Then, there are the Walmart haters, one of whom wrote to instruct me, "Walmart is never a good idea anywhere". The Broadway neighborhood residents will, I predict, also be split. The new gentrification crowd living in waterfront condos and apartments envisions a downtown of public squares, fine dining, outdoor concerts, boutique stores, and a grocery store featuring sushi and organics. Yet, the neighborhood is mostly other people with other priorities, fewer means, with limited budgets and limited transportation resources. Should they be denied access to something which may help them manage their finances and improve their families' situations?

There is a general consensus that good progress is being made in the redevelopment of downtown Green Bay. If the Walmart concept becomes a Walmart proposal, consensus will not be the order of the day.

July Meeting Notes. NEW Water Director Speaks to BCTA.

Monthly meeting of the Brown County Taxpayers Association meeting July 18, 2013 at Titletown Brewing Co.

Thomas Sigmund, P.E., Executive Director of the Green Bay Metropolitan Sewerage District (GBMSD) explained the GBMSD's new name: NEW Water. GBMSD has served Northeast Wisconsin for over 80 years. It will continue to be known as the Green Bay Metropolitan Sewerage District legally. It will continue to provide the same quality water treatment service. The new brand complements a new attitude of viewing materials received as a resource to be recovered, rather than a waste with which to dispose. NEW Water will be working closely with the greater Northeast Wisconsin community toward a common goal of clean water, an essential part of the quality of life in the watershed area. The GBMSD took over operation of the De Pere waste treatment facility in 2008.

GBMSD serves approximately 217,000 residents in a 285 square mile area. Customers of GBMSD include the Cities of De Pere and Green Bay; the Villages of Allouez, Ashwaubenon, Bellevue, Hobart, Howard, Luxemburg, Pulaski, and Suamico; the Towns of Green Bay, Humboldt, Lawrence, Ledgeview, Pittsfield, Red River, and Scott; and contract customer Procter & Gamble Paper Products Company.NEW Water serves approximately 217,000 residents in a 285 square mile area. Customers of NEW Water include the Cities of De Pere and Green Bay; the Villages of Allouez, Ashwaubenon, Bellevue, Hobart, Howard, Luxemburg, Pulaski, and Suamico; the Towns of Green Bay, Humboldt, Lawrence, Ledgeview, Pittsfield, Red River, and Scott; and contract customer Procter & Gamble Paper Products Company.

GBMSD does not bill residents directly for wastewater treatment service. GBMSD is a wholesaler of wastewater treatment service and provides a monthly bill to each municipality and one contract customer it serves. NEW Water does not bill residents directly for wastewater treatment service. NEW Water is a wholesaler of wastewater treatment service and provides a monthly bill to each municipality and the one contract customer it serves. Each community owns and maintains its own sewer pipes. Sewer rates charged to residents by the individual municipalities vary.

NEW Water is starting a project to replace its 1976 era solids incineration equipment with a new Resource Recovery and Electrical Energy generation system known as the R2E2 Project. \$150 million of equipment will be purchased this fall with construction occurring in the fall of 2014. The R2E2 Project is expected to cut GBMSD's annual energy costs in half during the first year (an estimated annual savings of more than \$2.2 million).

NEW Water anticipates about a 9% increase on its wholesale rate each year through 2016. Each municipality sets its own wastewater treatment rate, so the impact of these increases will vary by municipality. Generally, NEW Water's current charges make up less than half of the average household's sewerage charge, which is part of combined water and sewer bills.

Improvement in regional water resource quality continues to be elusive. This is largely due to nonpoint source pollutants. NEW Water faces a potential \$230 million cost for phosphorus reduction, even though it contributes only a tiny percentage of the total phosphorus discharge into the Fox River. Working cooperatively with other dischargers could save \$170 million of this cost.

As of the beginning of September, 2013, the U.S. National Debt had risen to an official total of \$16.92 Trillion. We note that this is only about \$30 Billion more than last reported the first of July. Energy Answers are NOT Blowing in the Wind.

No Wind = No Power.

A recent study by the Civitas Institute, a think tank based in England, finds "There is no economic case for wind-power." In England, there has been a significant movement against onshore wind turbines following concern about the health effects and unsightly appearance of gigantic industrial turbines covering the countryside.

The Civitas Institute study also warns that mandating certain targets for the percentage of electricity generated by renewable sources increases electric rates for families. In Wisconsin, we already have excess electric generation capacity without new power sources. So why are we building more?

Not only are wind turbines bad for people, they are bad for wildlife. Pro-wind advocates are always trumpeting the fact that wind energy (and all green energy) is good for the environment and good for consumers. Unfortunately, such statements aren't the truth. In addition to people's health and pocketbooks, wind is taking a toll on wildlife. In California alone, it is estimated that wind turbines kill 80 golden eagles (a protected species per year.

Under Wisconsin law, ten percent of the state's electricity must come from renewable energy by the end of 2015. As we near that goal, some in Madison are pushing for a higher renewable energy mandate. This is a bad idea. Imposing a higher renewable energy mandate will increase electric costs for hardworking families and businesses that employ them. This doesn't make economic sense.

An analysis of the renewable energy mandate currently in place estimates it will cost Wisconsin households almost \$800 million in higher electricity bills between 2013 and 2016 - this is money that could be spent or invested on other things.

This shows that the only way wind energy can compete with less-expensive methods of generating electricity is through costly government regulations, government and electric user subsidies.

In the free market, if wind energy could not pay for itself no company would be willing to supply it. But because the government has stepped in at the behest of an idealistic agenda to promote wind energy, we all are paying more than we should for the electricity that we use. The federal government says you can no longer tour the White House because it costs too much (even though the tours are given by volunteers), yet they have no problem spending billions of taxpayer dollars to extend green energy tax credits for another year, really. If wind energy is as good as the advocates claim, it should be on the same playing field as other energy generation. It should pay taxes instead of receiving tax subsidies and grants, instead of costing electric users more, it should cost less or the same. According to prowind groups, the industry couldn't survive without government subsidies. Free market economics, not crony capitalism of the left or right, what a common sense idea.

August Meeting Notes.

Monthly Brown County Taxpayers Association meeting held August 15, 2013 at Titletown Brewing Co.

The following committee reports were presented.

SCHOOLS: The budget passed by the Wisconsin Legislature placed some limitations on Community Service (Fund 80) expenditures by school districts. School Districts are now prohibited from levying more for community service activities in 2013-14 and 2014-15 than they did in the most recent year preceding 2013-14 in which the district levied for those activities. If a district wishes to exceed the limit on the community service levy, it can be done so through a referendum. School districts levying for community service activities in 2013-14 and 2014-15 are required to identify in the districts' budget summaries those expenditures that will be funded from that levy with a statement of how those expenditures meet the allowable criteria for use of the community service fund. The legislation freezes Fund 80 expenditures at previous levels, but it leaves Fund 80 outside property tax levy limits.

COUNTY/MUNICIPAL: The Green Bay City Council's decision to sell the Clarion Hotel to American Hospitality Management over Edgewater Resources was discussed. Major concerns with the Edgewater project were as follows:

* It seriously jeopardized the Hotel Northland project. Market data do not support the viability of over 350 luxury hotel rooms in the downtown area.

* The lack of affordable room options downtown could hinder the city's competitiveness for many conventions.

* The \$13 million in room tax commitments might be jeopardized. If the city isn't under construction before the end of 2013, the city could lose its main funding source.

* Edgewater's financing package and income projections were questionable.

* There were many open-ended questions about the expected level of city participation in the Edgewater project.

The Neville Public Museum is requesting \$100,000 from the Brown County Board to begin a master plan for the museum. The request is to tap into the County's general fund reserves.

Rep. Chad Weininger reported the Federal Reserve Bank of Philadelphia announced that Wisconsin had the third best economic growth in the nation, and the Dept. of Revenue reports state tax collections up 4.2% over last year. Both positive indications.

In many ways, the USPS is a perfect example of how not to run a business. No matter how hard they try to operate at a profit, they just keep getting deeper in the hole. No question the main problem is Congress, who sets the rules, generally rejecting any sensible money saving ideas such as eliminating Saturday delivery, nonprofitable offices, or selective rate increases on services costing more than they earn.

We were surprised by a recent *New York Times* article which disclosed that for several years the post office has been photographing the face of every piece of mail processed in the United States: 160 Billion pieces last year alone, While the methodology was not disclosed, under any circumstances this would be a huge, expensive and time consuming operation, even with modern equipment.

If true, and who would question the *New York Times*, we wonder who's idea it was and where they are going with it. The USPS may justify their actions as a safeguard against Ricin and Anthrax attacks. An item in the Sept. 1, issue of *Forbes* noted that at \$91,054 per family, Washington D.C., had the highest median household income in the country. Considering the city has no manufacturing base, or any of the other factors that make places like New York, Los Angeles, etc., prosperous, it appears that as much as they complain, working for the government pays quite well. It's with our money.

The Federal Student Loan Program was established to assist college students meet the high costs of obtaining a college education, and therefor the overall living standards of the country. For the most part it probably rates as a success.

However, as with just about any massive federal initiative prepared with good intentions things can get out of control in the programs administration. At present, there are about \$1.2 Trillion in student loans **outstanding**, accounting for a good portion of our National Debt. About a third of the total is behind in payment or in default.

In addition 1.6 Million borrowers have already applied for the government's stealth bailout program allowing debt forgiveness under certain circumstances including the obligation of the student loan prevents graduates from being able to get married or buy a home after graduation. Unfortunately a government loan to get a college degree does not guarantee a job.

President Obama, in one of his recent and rousing college speeches, suggested a plan to tie federal aid and student loans based on each schools *"frugality rating,"* or how well they manage their finances based on a formula yet to be determined by Congress. In other words, student loans could be tied more directly to a schools tuition costs as determined by each schools own circumstances.

While this may sound great, it will unlikely ever happen. As much as we can be proud of our colleges and their accomplishments, by nature most of them have never been noted for operating on a tight budget. *Time Magazine* notes that since 1985 college costs have gone up 500%, or double that of items such as food, gasoline or housing. They are in a position to raise tuitions at will and still compete with other schools to have the best faculties, facilities, and wealthy alumni. As long as they have a waiting list they are happy.

Secondly, the President using the term "frugality rating" is a blatant example of reference to a technology he seems to know very little about as evidenced by our government under his watch's disrespect for spending the taxpayers money.

The Teamsters Union is always on the lookout for new industries to add to their control. Good taste or public opinion has never been an obstacle for them. An item in the *National Review* reports that in the Chicago they have resorted to soliciting Funeral Homes to join their union.

They had been picketing prospects, and harassing mourners with all of the techniques at their disposal until a judge ordered them to stop.

The mega-casino proposed by the Menominee Tribe near Kenosha had been on hold until the Bureau Of Indian Affairs (BOIA) recently endorsed the project. We acknowledge there are many pros and cons to be considered here, but it would seem that the state should have final approval, along with the consent of the majority of our population rather than the Washington bureaucrats.

Obviously the location is ideal due to the traffic from Illinois on I-94. Economically it should be a success and quite likely accomplish the goals for employment and income that have been announced. As we are all well aware, a number of impressive and successful casinos have been built by various tribes in recent years. However, patronizing them is a matter of personal choice and most people realize and respect this.

If this project proceeds, it will probably only be a matter of time until cash-starved Illinois finds a way to construct even larger casinos on their side of the border, and other Wisconsin tribes will justify continuing to expand their operations. This has been the pattern to date, at times creating more problems than were solved.

With all respect to the tribes and their economic problems, shouldn't the real question be: *How far does Wisconsin want to go towards becoming the Las Vegas of the Great Lakes?*

Finally, received a notice the other day from our municipal assessor that they have lowered the valuation on our residence by 9% or so. The reason given was the depreciating value of real estate due to the economy.

The bad news is that my investment in a home is also worth less. The real bad news is that my property tax bill this year can and probably will still be higher than last years.
